**ORDER TO ISSUE NOTICE TO CREDITORS**

This matter comes before the Court on the Receiver, L. Vance Brown's Application for Order to Issue Notice to Creditors ("Application"). Upon reviewing the Application, the Court agrees that to better track, index, and ultimately pay the outstanding creditors alleging claims against the Receivership estates of Jasmine, Inc., Oklahoma Energy Exchange, LLC, Gates Oil & Gas, LTD., Harrisburg Prospect Lease Fund, LLC, and/or Harrisburg 2 Prospect Lease Fund, LLC, the Receiver should provide a Notice to Creditors, and the Court should set a deadline to finalize any such claims against the Receivership Estates so that they might be better administered. Accordingly, the Receiver's Application for Order to Issue Notice to Creditors is hereby GRANTED.

The Receiver is therefore ORDERED to:

1. Cause a Notice to Creditors in a form substantially similar to the Exhibit A attached to his Application be filed with this Court and that said Notice:
  - a. Direct all creditors of the Entities to present their claims to the Receiver no less than 60 days from the date of filing, lest their claims be forever barred;

- b. Be published in each an Oklahoma County, Oklahoma; Stephens County, Oklahoma; and Garvin County, Oklahoma newspaper once each week for two (2) consecutive weeks from the date of filing; and
  - c. Be mailed to all known creditors at their last known available addresses by regular first-class mail.
2. File an Affidavit of mailing listing all creditors and addresses to which said Notice was mailed; and
3. File an Affidavit of Publication from each of the above-mentioned county newspapers.


